#### प्रस्तावना–

हिन्दी केवल खड़ी बोली नहीं है, बल्कि एक बहुत बड़ा भाषिक समूह है। हिन्दी जगत में अनेक विभाषाएं, बोलियाँ और उपबोलियाँ विद्यमान हैं जिनमें सकल साहित्य सम्पदा है। इनके सम्यक अध्ययन और अन्वेषण की आवश्यकता है। जनपदीय भाषा छत्तीसगढ़ी निरन्तर विकास की ओर अग्रसर हो रही है अस्तु, इस भाषा का और इसमें रचित साहित्य का इतिहास— विकास स्पष्ट करते हुए इनसे संबंधित प्रमुख रचनाकारों का आलोचनात्मक अनुशीलन करना हिन्दी के वृहत्तर हित में होगा। छत्तीसगढ़ी भाषा का पाठ्यकम निम्न बिन्दुओं पर आधारित हैं—




